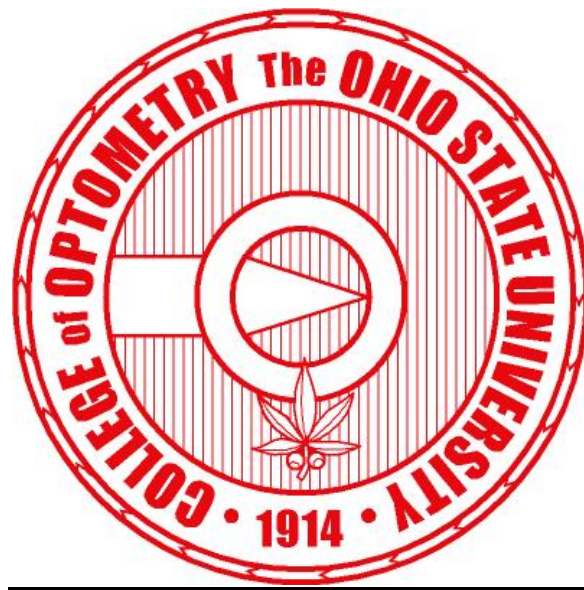

# College of Optometry



## **CURRICULUM INFORMATION**

The College's optometry program is 14 quarters over four years. The curriculum begins with basic sciences, transitions to clinical courses, and concludes with a rich patient-based experience. Pre-clinical optometry courses cover the areas of general optometry and optometric specialties. Clinical courses provide the opportunity to work with patients in primary vision care and special services. Patient care begins in the second year, expands in the third year, and is nearly full time throughout the fourth year. Three extern programs in the fourth year provide hands-on exposure to co-management clinics, VA hospitals, ophthalmology clinics, primary care and community practice settings, and other facilities.

## **ACADEMIC STANDARDS AND POLICIES**

### **ACADEMIC STANDARDS**

#### **Minimum Scholastic Standards**

The faculty of the College of Optometry has established academic standards and policies pertaining to the warning, probation, and dismissal of optometry students (Rule 3335--9-23 of the Administrative Code). All rules as listed in the university Master Schedule and Code of Student Conduct apply. Only those courses which are part of the optometry curriculum shall be included in the calculation of point-hour ratios for students enrolled in the College of Optometry.

In order to advance and be permitted to enroll in any quarter beyond the first quarter, students must achieve the following minimum scholastic requirements:

- to the second or third quarter, attainment of a minimum cumulative point-hour ratio of 1.50;
- to the fourth, fifth, or sixth quarter, attainment of a minimum cumulative point-hour ratio of 1.90 at the end of the immediately preceding quarter;
- to the seventh quarter, attainment of a minimum cumulative point-hour ratio of 2.00 at the end of the sixth quarter; and

- to the eighth or any subsequent quarter, a minimum cumulative point-hour ratio of 2.00 at the end of the immediately preceding quarter.

### **Warning**

Any student subject to the provisions of the minimum scholastic requirements rule who fails to achieve a point-hour ratio of 2.00 on the work of any quarter will be on warning.

### **Probation**

Unless dismissed pursuant with the stipulations of the rule, any student subject to the provisions of the minimum scholastic requirements will be on probation if the minimum cumulative point-hour ratio is:

- below 1.80 at the end of the first or second quarter; or
- below 2.15 at the end of the third or any subsequent quarter up to the quarter of graduation (for which a cumulative point-hour ratio of 2.00 is required).

Other conditions of probation may be established by the College of Optometry Executive Committee.

Effective March 26, 2007, the College of Optometry Executive Committee established additional policy pertaining to probation and dismissal .

The sequential nature of the Doctor of Optometry program requires that a student be enrolled in a specific year of the four year curriculum. All courses in a particular year must be successfully completed before entering the subsequent year's curriculum.

A student who receives an "E" grade during the program shall be placed on academic probation.

A student who receives an "E" grade in any course will not be allowed to continue into the next year of the program until the course is successfully completed.

A student repeating coursework due to receiving an "E" grade must retake, for credit, any other of that quarter's course(s) in which she/he received a "D" grade, and officially audit all of the other courses during the quarter she/he is repeating.

Students shall be notified of probationary status by the College in writing. Such notifications shall include a clear statement of what shall be required of the student academically in order to avoid dismissal.

### **Dismissal**

- If a student receives two or more "E" or "U" grades during the program, she/he shall be eligible for dismissal.
- Failure to meet the minimum scholastic requirements shall result in dismissal from the College of Optometry as of the end of the quarter in which such failure occurs.
- If at any time the preparation, progress, or success of a student in the assigned work is determined to be repeatedly unsatisfactory, or if there is egregious activity, for example causing risk to patient safety or falsification of clinical data, then the executive committee of the College of Optometry shall, after deliberate review, be empowered to dismiss him or her from the College of Optometry.
- Written notice of dismissal from the college or university shall be sent by the dean of the College of Optometry to the student
- A dismissal for failure to meet the minimum scholastic requirements or for a student who has received two or more E grades may be waived for educationally sound reasons through special action of the Executive Committee of the College of Optometry

## **Reinstatement**

A dismissed optometry student may petition to be reinstated after a period of three quarters. Such a petition will be considered only in the event that the class to which he or she wishes to be reinstated has a vacancy.

Any student who may be reinstated by the Executive Committee of the College of Optometry following dismissal shall be subject to such special requirements as may be determined appropriate by the Executive Committee. If the performance records of any reinstated student do not meet the conditions specified at the time of reinstatement, then the Executive Committee shall consider all the facts in the student's case and determine whether dismissal by special action or a waiver for another quarter is indicated.

## **REMEDICATION OF CLINICAL COURSE WORK (REVISED 1/11)**

### **Purpose:**

To document a threshold of performance and the procedures to initiate remediation of inadequate student clinical performance and progress; and to improve consistency and calibration of faculty grading in clinical courses.

### **Remediation Committee:**

This process is mandatory when a student receives a "C-" grade in any clinic course. The purpose of this committee is to work in the best interest of the student, the faculty, the institution, and its patients to plan a remediation program designed to raise the student's performance above the minimum competency level to the satisfaction of the faculty member of record for the clinic course in which the C- grade was given. This process will seek multiple sources of feedback and will operate with respect for student confidentiality. The ad hoc Remediation Committee appointed by the Associate Dean or other College administrator with jurisdiction over the professional program will consist of:

(1) The faculty member(s) of record for the clinic course(s) in which the student received a C- grade; (2) A faculty member who will serve as Committee chairman; (3) the Associate Dean with jurisdiction over the professional program; and (4) a representative of the Office of Student Affairs, who will serve as a non-voting member.

The Remediation Committee will be appointed, meet, and initiate the remediation program in a timely fashion.

### **Remediation of Clinical Coursework:**

When a student is identified for remediation of clinical coursework, the faculty member of record will assign the student an "I" (Incomplete) for the course and the alternate grade will be an "E" for the course. The Remediation Committee will establish the remediation program and determine the period of time for the remediation process. When the remediation is successfully completed, it is recommended that the final grade be changed from the I/alternate back to the originally proposed C- grade. If the student does not successfully complete the remediation, the final grade will be an "E" for the course. From spring quarter of the third year of the professional program on, this automatic remediation does not take place. Instead, a C- grade in clinic coursework from that point onward will be referred to the College Executive Committee for action with input from the Director of Student Affairs.

This remediation plan will be signed by the student, and a copy will be given to the Remediation Committee members, the Dean, the Clinic Director, the Clinic Chief associated with the clinic course(s) in question, and the student.

A written report of the progress of the student will be submitted to the aforementioned individuals at subsequent mid-quarter and final grading periods until the student is off remediation or dismissed.

## **ACADEMIC POLICIES**

### **Class Attendance/Absence**

The faculty of the College of Optometry expects curricular commitments to be top priority for our students. **Regular attendance for scheduled work is required** (Rule 3335-9-21 of the Administrative Code). Students who are frequently absent from classes and laboratories will be reported by the instructors concerned to the dean of the College, who may take any action deemed necessary in an individual case.

Certain situations, such as attendance at professional meetings, illnesses, or emergency family situations, may require students to occasionally miss class or clinic (for information on clinic attendance/absence see the "Policy and Procedures for The Optometry Services" manual). In these circumstances, students must notify The Office of Student Affairs (614-292-2647, [admissions@optometry.osu.edu](mailto:admissions@optometry.osu.edu)) and their didactic and clinical course instructors (and Carol Wilcox (formerly Maser), clinic scheduler, if missing clinic) via **phone and email** for day-of absences due to illness or emergency situations, and **via email** in advance of planned absence days. Individual course instructors will determine how and when missed course work/examinations will be completed.

### **Examinations**

Final examinations are scheduled at the close of each course, except in laboratory and seminar courses where they are optional. Final exam schedules are arranged by the College office for those courses in which only students in the College of Optometry are enrolled. Each quarter's final exam schedule will be made available to students as soon as it is finalized (typically two to three weeks prior to the end of the term). Examinations for non-Optometry courses are scheduled by the University Scheduling Office.

### **Marking and Point Systems**

The grades used by the College of Optometry and their equivalent points are: A (4.00), A- (3.70), B+ (3.30), B (3.00), B- (2.70), C+ (2.30), C (2.00), C- (1.70), D+ (1.30), D (1.00), E (failed, no points). Other marks which may be used are EM, I, K, NP, P, PA, R, S, U, or W. See the Course Offerings Bulletin for definitions (may be accessed on-line at [www.ureg.ohio-state.edu/courses/](http://www.ureg.ohio-state.edu/courses/) - follow the links for Course Bulletin text).

### **Report of Marks**

Upon completion of the course requirements, marks for every student are reported to the Office of the University Registrar in accord with deadlines listed in the quarterly Master Schedule of Classes. This office maintains the student's official permanent record and is responsible for issuing a quarterly grade report (via e-mail) to each student.

### **Policy on Student Calculator Use in Examinations (Approved: 04/06/2011)**

The purpose of this policy is to restrict calculators to those that are non-programmable and have no connectivity, if the instructor of record allows for the use of calculators during an examination in a course. This will ensure that no students are unfairly advantaged or disadvantaged. Allowable calculators include the TI-30Xa, TI-30X IIS, TI-34 II, and TI-36X. Any calculator in the TI-30 series or with a similar level of functionality is permissible. Students whose calculators are not in the TI-30 series must have their calculators approved by the instructor at the beginning of the term.

In addition, no other electronic devices are allowed during examinations. This includes mobile phones, PDAs, iPods, MP3 players, etc. This applies even if only calculator functions on those devices are being used. Any

exceptions to this policy must be explicitly approved by the instructor in advance of the exam. A violation of this policy constitutes a violation of the Honor Code.

### **Withdrawal from the Doctor of Optometry program**

A student who desires to withdraw from the College must apply to the dean for permission to withdraw. No student may withdraw within two weeks of the beginning of final examinations unless the reports of his or her instructors show that his or her record as of that date is satisfactory. If you are considering withdrawing from the College, please feel free to consult with staff in the Office of Student Affairs for pertinent information before submitting your request for permission to withdraw to the dean.

### **DEBTS AND FINES**

Registration is conditional upon payment of fees.

- (A) All bills, fees, and deposits required from students for a quarter, semester, or session, must be paid at the Office of Fees and Deposits prior to, and as a condition of, registration for that quarter, semester, or session.
- (B) On the first day of class each quarter, semester, or session, each student is required to demonstrate the right to enrollment in scheduled classes by presentation of an approved schedule or appropriate change document and paid fee receipt. (3335-9-12 Rules of the University Faculty.)

It is the policy of The Ohio State University that a student may be denied subsequent registration or the release of an academic transcript, if he or she fails to pay a debt owed to:

- (1) The University residence halls for room, board, services, or damages; or
- (2) an office or department of the University; or
- (3) a University judicatory body for fines imposed in accordance with the rules of The Ohio State University, provided that any creditor listed above furnishes an itemized written certification of the debt or fine and establishes that all reasonable collection efforts have been exhausted.

### **ACADEMIC MISCONDUCT**

Issues of academic misconduct within the College of Optometry are handled through the College Honor Code (Rule 3335-5-54 of the Administrative Code).

### **COLLEGE OF OPTOMETRY HONOR CODE**

The profession of optometry, like all health care professions, requires of its members a code of ethics and a standard of professional behavior which will meet the demands of the public and the standards of the academic and scientific community. ### **STUDENT GRIEVANCES**

Students who have grievances related to their enrollment in the College of Optometry (e.g., academic or personal concerns) may pursue a variety of options to seek resolution. It is usually best for all concerned to try to resolve any dispute or grievance as directly as possible, with the person(s) most closely involved with the problem. If this does not produce an acceptable outcome, students are encouraged to contact a Student Affairs staff member for advice and assistance (Fourth floor Starling Loving Hall, 292-2647). In some cases, students with grievances may request to meet with the College Executive Committee (the Dean, Associate and Assistant Deans, and Research Officer). Students seeking assistance beyond the College may contact the Student Advocacy Center, 292-1111.

### **COMBINED DEGREE PROGRAMS**

Students enrolled in the College of Optometry may register concurrently in either the Colleges of the Arts and Sciences or the Graduate School.

#### ***Optometry/Arts and Sciences B.S. Vision Science degree***

Optometry students whose cumulative point-hour ratios are 2.00 or higher may pursue a Bachelor of Science in Vision Science degree in the Colleges of the Arts and Sciences.

This program requires dual registration without any modification of the degree requirements for either college. Students must therefore arrange their schedules to allow at least three quarters between the award of the first degree (B.S. Vision Science) and the second (Doctor of Optometry). Students in this program may choose to work toward their baccalaureate degree with distinction.

***OD/MS Vision Science program:*** A combined program is available to outstanding students enrolled at The Ohio State University College of Optometry who wish to pursue the Masters and the O.D. degrees simultaneously. Optometry students may apply for admission to this program no sooner than the beginning of their second year. Admission of applicants is based on the student's academic performance and the Graduate Studies Committee's assessment of his or her motivation and capability to complete a program of independent research in combination with the regular optometry curriculum. Under this plan, up to 15 quarter hours of coursework in the optometry curriculum may be counted toward the required hours for both degrees. The completion of an independent research project and a thesis is required.

***OD/MPH program :*** The Colleges of Optometry and Public Health recently initiated a new combined degree program that will allow students to earn the Doctor of Optometry and Master in Public Health degree in five years. The Doctor of Optometry/Master of Public Health (OD/MPH) combined degree program simultaneously prepares students for the professional practice of optometry as well as providing knowledge and skills in the broader population health context.

Depending on the student's choice of specialization within the MPH, the program could lead to a wide variety of career options. Challenging and exciting opportunities exist in the public and private sectors developing skills in community-based optometry. An OD/MPH holder might assume leadership roles in academia/research, governmental agencies, and other health-related organizations as well as in professional practice.

Due to efficiencies in scheduling and the ability to count some work toward both degrees, the degrees can be completed within 5 years of study (approximately 2 quarters sooner than pursuing the degrees separately), and they can be received at the same graduation ceremony.

This combined degree program is the first program of its kind in Ohio, and in the country.

## **Curriculum**

Ohio State has long been known as an innovator in optometric education, and the OD/MPH builds upon that experience to offer a rigorous but realistic program. There are three options for students completing the program:

**Option 1:** Students will complete the first year of coursework in the MPH program and then enter the Optometry program, completing both programs in four more years.

**Option 2:** Students will begin study in the optometry curriculum, and then transfer to the MPH program for one year of full-time graduate study. The specific years of the optometry program between which the MPH program can occur would be decided on an individual basis by agreement of both programs.

In both options 1 and 2 the student will complete a public health practicum and a culminating project determined by the student's field of specialization in the MPH, typically an applied research project, concurrent with the fourth-year optometry clinical rotations.

**Option 3:** Students will complete the four-year OD degree while taking a few courses in the MPH program and would then do full-time MPH graduate work in year five.

These three curricular options will allow for recruitment of students who are committed to seeking both degrees at initial enrollment, as well as students who may become familiar with the combined degree program at some point during their Doctor of Optometry program.

## **Application Process**

Students who wish to pursue the OD/MPH must apply to and be admitted separately to each program. Students may apply to both programs concurrently, completing the appropriate application processes for each program and paying all relevant application fees.

## **GRADUATION INFORMATION**

To be eligible to receive the Doctor of Optometry degree, a candidate must:

- complete the general admission requirements;
- complete the prescribed courses of the professional curriculum to total a minimum of 216 quarter credit hours;
- achieve a minimum cumulative point -hour ratio of 2.00 on all courses undertaken at this University; and
- achieve a minimum cumulative point -hour ratio of 2.00 on all courses in the optometry curriculum.

## **Graduation With Honors**

The honors designation of *cum laude*, *magna cum laude*, or *summa cum laude* is conferred upon selected graduates of the College of Optometry. These designations are awarded to those graduates who have achieved

superior scholarship on the basis of their academic record in the College. The cumulative point-hour ratio required for the degree *cum laude*, *magna cum laude*, or *summa cum laude* is determined annually. Because the grade point criteria for these awards may vary from year to year, please contact the College Office of Student Affairs for current information.

### **Commencement/Convocation**

University Commencement is scheduled at the close of each quarter for the conferring of degrees upon candidates who have fulfilled all the requirements of their respective programs. College of Optometry students typically graduate with their OD degrees in Spring Quarter, although alterations to a student's course plan (leave of absence, required course repetition due to course failure) may mean that student would graduate during a quarter other than spring. The College holds an annual Doctoral Convocation program preceding the Spring Quarter University commencement ceremony. At the Convocation program, students receive their Doctor of Optometry hoods.

### **Certification**

It is important for every student to understand that, while certain curricula are designed for the purpose of achieving registration or certification by an outside agency, or both, completion of such an academic program in no way assures the student of successful registration or certification. No employee, agent, or representative of this University is authorized or empowered to provide such assurances either directly or by implication.

### **Licensure Requirements**

Before obtaining a license to practice optometry in a given state or the District of Columbia, a graduate must pass written and practical examinations given by the Board of Optometry of that state. A number of states accept passing of the written examination of the National Board of Examiners in Optometry in lieu of their own state's written examination. The National Board of Optometry examination is given at each college of optometry in the United States, usually in April, August and December of each year. The College is accredited; therefore, its graduates are eligible to take optometry board examinations in each of the 50 states, as well as the District of Columbia.

## **HEALTH REQUIREMENTS**

All College of Optometry students must meet the following health requirements on entering the program, and prior to patient contact:

### **Entry Requirements:**

- Completion of the *Immunization Record and History of Past Infection* section on The Ohio State University Student Health Service form entitled *IMMUNIZATION AND HEALTH SCREEN*. This form documents the completion of the following vaccinations or tests:
  - Measles, Mumps, Rubella (MMR)
  - Adult Tetanus/Diphtheria
  - Chickenpox history
  -

### **Patient Contact Requirements:**

- Documentation of complete Hepatitis B immunization series (this is a three-shot immunization series that can be completed at the OSU Student Health Service)
- **Annual** two-step PPD testing (not TB-tine test). This test can be also be completed at the OSU Student Health Service. Note: If PPD test is positive, a chest x-ray will be performed. If the chest x-ray is positive, documentation of appropriate treatment must be provided.

Each year the Student Health Service provides special group Hepatitis B immunization and PPD testing clinics for Optometry students (clinic dates, times, shot/testing fees and other details are provided via e-mail). The clinics provide a convenient way for students to complete these important health requirements. You may also

complete the Hepatitis B immunization and PPD testing requirements through individual appointments at the Student Health Center; to schedule an appointment please call 292-4321. **NOTE: Students completing the Hepatitis B series and PPD testing through other health care offices must provide written documentation of completed requirements to Susan Baker, R.N., at Student Health Services (fax: 614- 292-6001, address, 320 Wilce Student Health Center, 1875 Millikin Rd., Columbus, OH 43210).**

Please direct any questions about either the entry or pre-patient care health requirements to Ms. Baker at Student Health Services.

### **PATIENT CARE**

The Ohio State University Optometry services are internationally recognized for their excellence in patient care and research. Ohio State's Optometry Services are open to the public, not just to staff and students at the University. The clinics offer eye and vision examinations. Prescription lenses, frames and contact lenses can be ordered. Many optometric services are reimbursable through vision plans or private insurance programs.

The Ohio State Optometry Clinics are known for their contributions to the advancement of patient care. In addition to eye and vision examinations, services include vision training and orthoptics programs, low vision and visual rehabilitation, the diagnosis, treatment and management of ocular diseases, pediatric vision care, aniseikonia testing, and meeting all eyewear and vision needs.

Patients who are ordering prescription eyewear may visit the College Eyewear Gallery for Great Vision to) choose from a large selection of designer frames, as well as modestly priced frames. Patients who need specialized occupational or cosmetic lenses, frames and tints will find these available also.

Through the Ohio State University Optometry Services, our students are given the opportunity to provide optimal comprehensive vision and eye health to our patients. Eye care is delivered with professionalism and "best practices."

### **REMEDICATION OF CLINICAL COURSE WORK (REVISED 1/11)**

#### **Purpose:**

To document a threshold of performance and the procedures to initiate remediation of inadequate student clinical performance and progress; and to improve consistency and calibration of faculty grading in clinical courses.

#### **Remediation Committee:**

This process is mandatory when a student receives a “C-” grade in any clinic course. The purpose of this committee is to work in the best interest of the student, the faculty, the institution, and its patients to plan a remediation program designed to raise the student’s performance above the minimum competency level to the satisfaction of the faculty member of record for the clinic course in which the C- grade was given. This process will seek multiple sources of feedback and will operate with respect for student confidentiality.

The ad hoc Remediation Committee appointed by the Associate Dean or other College administrator with jurisdiction over the professional program will consist of:

- (1) The faculty member(s) of record for the clinic course(s) in which the student received a C- grade;
- (2) A faculty member who will serve as Committee chairman;
- (3) the Associate Dean with jurisdiction over the professional program; and
- (4) a representative of the Office of Student Affairs, who will serve as a non-voting member.

The Remediation Committee will be appointed, meet, and initiate the remediation program in a timely fashion.

### **Remediation of Clinical Coursework:**

When a student is identified for remediation of clinical coursework, the faculty member of record will assign the student an “I” (Incomplete) for the course and the alternate grade will be an “E” for the course. The Remediation Committee will establish the remediation program and determine the period of time for the remediation process. When the remediation is successfully completed, it is recommended that the final grade be changed from the I/alternate back to the originally proposed C- grade. If the student does not successfully complete the remediation, the final grade will be an “E” for the course. From spring quarter of the third year of the professional program on, this automatic remediation does not take place. Instead, a C- grade in clinic coursework from that point onward will be referred to the College Executive Committee for action with input from the Director of Student Affairs.

This remediation plan will be signed by the student, and a copy will be given to the Remediation Committee members, the Dean, the Clinic Director, the Clinic Chief associated with the clinic course(s) in question, and the student.

A written report of the progress of the student will be submitted to the aforementioned individuals at subsequent mid-quarter and final grading periods until the student is off remediation or dismissed.

## **PRIMARY VISION CARE SERVICE**

The Primary Vision Care Service provides thorough eye examinations, which include a complete medical and visual case history and a comprehensive analysis of ocular health and visual performance. The results of this eye examination will lead to an optimum spectacle prescription for safety and visual performance. A dilated pupil eye examination will also detect the presence of eye diseases, such as cataracts and glaucoma. If additional testing or treatment is indicated, the patient may be referred to one of our specialty services.

### ***CONTACT LENS SERVICE***

The Contact Lens Service offers a complete range of contact lens materials, replacement schedules, and care systems for patients who wish to experience the many advantages of wearing contact lenses. Daily, extended and continuous wear contact lenses are all available. In addition, we offer special contact lens designs for astigmatism, bifocals, cosmetics, keratoconus, corneal disease and ocular trauma. Ocular prosthetic service is also available.

### ***VISION REHABILITATION SERVICE***

The Vision Rehabilitation Service assists patients who have permanent vision loss as a result of eye injuries or diseases. Traditional methods of correcting blurred vision, such as glasses and contact lenses, may not provide these patients with adequate vision for their needs. The latest technology in visual aids, such as telescopes, microscopes, electronic devices, and adaptive equipment are used to help each patient regain as much independence as possible. Both visual aids and education are utilized to improve the patient's functional vision for work, home, school, and other environments.

### ***BINOCULAR VISION / PEDIATRICS SERVICE***

The Binocular Vision Service provides treatment options for patients with crossed eyes (strabismus), focusing problems, lazy eye (amblyopia), eye movement inefficiencies, and dyslexia. Patients with binocular vision difficulties may experience eye strain, headache, double or blurred vision. Binocular vision problems in children may present as reduced concentration, avoidance of near work, poor eye-hand coordination, reduced athletic performance, or other learning challenges. If not diagnosed and treated at an early age, lazy eye and crossed eyes may lead to permanent vision loss. These symptoms may be lessened or eliminated with an individualized treatment program of vision therapy, spectacle lens wear, and/or eye patching. This service also offers care for rehabilitation of traumatic brain injury patients.

A comprehensive **aniseikonia service** is available within the Binocular Vision Service. It is one of only a few clinics in the United States which provides diagnoses and treatment options for patients with symptoms caused by a significant difference in spectacle prescription between the two eyes. Symptoms may include eyestrain, headaches and distorted vision. Using highly specialized instrumentation and testing techniques, these symptoms may be lessened or eliminated with an individualized treatment program consisting of specially designed spectacle lenses or contact lenses.

### ***PEDIATRIC SERVICE***

The Pediatric Services offers comprehensive vision examinations for infants, toddlers, children under the age of 13, and exceptional needs patients. Children often do not know how they should be seeing because they assume that everyone sees the way they do. Comprehensive eye examinations are recommended at critical stages in their visual development - by 6 months of age, at 3 years of age, before first grade, and then every 2 years throughout the school years. Children with signs or symptoms of vision problems should be examined as soon as possible.

### ***HOME-BOUND AND NURSING HOME CARE SERVICE***

The Home-Bound and Nursing Home Care Service provides eye examinations and eyewear for patients in central Ohio who are unable to travel and would not otherwise receive eye and vision health care. This service provides thorough eye examinations, which include a medical and visual case history and a comprehensive analysis of ocular health and visual performance. The results of this eye examination will lead to an optimum spectacle prescription for visual performance. A dilated pupil eye examination will also detect the presence of eye diseases, such as cataracts, diabetic retinopathy, and glaucoma.

## ***OCULAR DISEASE SERVICE***

The Ocular Disease Service provides care for patients with both acute and chronic eye problems. Examples include infections, dry eyes, iritis, cataracts, glaucoma, and diabetic retinopathy. Our special testing facility utilizes state of the art instrumentation needed for the diagnosis and management of many ocular diseases. Faculty in our Ocular Disease Service are experts in diagnosis and treatment of diseases affecting any part of the eye or visual system. We provide consultation and care for patients interested in cataract and refractive surgery staffed by clinicians and researchers who develop and teach the latest techniques. We have also established a world class center for study and treatment of dry eyes. Our students and faculty are experienced working with referring doctors and primary care physicians to coordinate your eye care with other health care providers. Urgent care services are available. Patients can access these services after hours by calling the paging telephone number.

## ***EYEWEAR GALLERY FOR GREAT VISION***

Our Eyewear Gallery for Great Vision collection of over 1600 frames is unsurpassed in all of Ohio. The staff of licensed opticians specializes in matching our patient's visual and lifestyle needs to specific lens options. Unlike most retail and independent operations, we have the choice of all lens manufacturers when recommending a lens to our patient. We conduct independent studies on lenses and understand the strengths and limitations of each. This allows our optical professionals to recommend the best lens for each patient.

## **EXTERNSHIP PROGRAMS**

All fourth-year students are required to participate in three one-quarter externship experiences. This component of the curriculum provides students with hands-on exposure to co-management clinics, VA hospitals, ophthalmology clinics, primary care settings, community practice settings, and other facilities. The "Disease Extern" program is focused on diagnosis and management of ocular disease, as is the "Advanced Clinical Optometric Practice Extern." The "Primary Care Extern" program is focused on various private practice settings and experiences.

The Disease Extern program gives students the opportunity to see hundreds of patients, working with conditions such as cataract pre- and post-op, glaucoma management, and diabetes, as well as the opportunity to focus on patient pathology.

### **PRIMARY CARE EXTERN PROGRAM**

The primary care extern involves experiences in clinical practice at a variety of practice settings providing broad exposure to what constitutes contemporary primary eye care. Extern students have a rotation of clinical sites, each of which generates exposure to a specific patient population or clinical sub-specialty. Examples of primary care extern sites include exemplary optometric and ophthalmology practices,

ophthalmology referral centers and clinics, The OSU student health center optometry clinic, and The OSU College of Optometry Community Outreach Clinics. This course involves special emphasis on adapting to diverse patient encounters in unique environments and practice settings.

### **ADVANCED CLINICAL OPTOMETRIC PRACTICE EXTERN PROGRAM**

This extern program features clinical experience in optometry practice with special emphasis on patient populations that have or are at high risk for ocular disease and ocular manifestations of systemic disease. This experience includes approximately 40 hours per week in a Veterans Administration Medical facility or in a multi-specialty ophthalmology practice where there is an OD preceptor or a large comprehensive care optometry practice. This externship typically involves extensive clinical experience in diagnosing and managing acute and chronic ocular disease. It may also involve advanced clinical practice experience in pediatrics, vision therapy, contact lenses, low vision, and other areas.

### **INTERDISCIPLINARY SPECIALIZATION IN AGING**

The College of Optometry is the first professional program on campus to offer a program in Interdisciplinary Specialization in Aging for its students. The program arose from an effort to coordinate geriatric/gerontology activities among the programs within the health sciences. Optometry students who elect to pursue the specialization are required to complete an extra 21 hours of course work which concentrate on various aspects of aging. Approximately one-third of the hours involve optometric clinical activities such as extra vision rehabilitation clinic or nursing home care. The remaining two-thirds of the hours are from courses taught outside of the College of Optometry allowing our students to obtain different perspectives of the aging process and the caring for the aged.

### **RESIDENCY PROGRAM INFORMATION**

The Ohio State University College of Optometry is fortunate to be affiliated with seven residency sites. Each of the programs offers residents a wide variety of experiences making each program unique. The mission of the residency program is to prepare well-trained optometrists for numerous optometry and vision science opportunities, including optometric education and research. ### **RESEARCH and INVESTIGATION**

Since the Optometry Clinics provide educational experience for optometric students, each patient is scheduled with both a faculty optometrist and an optometry student. In keeping with Ohio State's tradition of excellence, patient needs can be met using the most extensive and technologically sophisticated instrumentation available anywhere in the world. Detailed measurements using advanced diagnostic equipment are utilized as needed. Examples are the electrodiagnostic units (to measure brain electrical activity while seeing), ocular photography units (to record external and internal abnormalities), and computerized visual field analysis (automated means of measuring peripheral vision).

The Optometry Clinics have long pioneered advancements in visual science. Examples of recent clinical developments include disposable soft contact lenses, the accurate measurement of fixation disparity and eye alignment, the effect of the pupil size on vision, the chemical analysis of tears, the electronic measurement of ocular pressure to detect glaucoma, investigation of how clearly infants see, the quality of color vision, and the oxygen consumption of the cornea.

## **STAYING SAFE**

Safety is a concern everywhere in society, including college campuses. You should therefore have a healthy concern for your own protection and property.

While the majority of criminal activity on campus is theft related, crimes against the person do occasionally occur, and residents should plan to become proficient in basic self protection and crime prevention techniques. An understanding of some basic safety principles, a little caution, and a lot of common sense is probably the best personal protection.

Numerous precautions are taken to ensure your safety while you are on campus. The Department of University Public Safety provides a range of services designed to protect the lives and property of students. University Police officers are assigned to a twenty four hour a day operation, seven days a week. This work scheduling ensures effective police response associated with order maintenance, crime control, and general police services. A pronounced police effort is to achieve public safety goals through existing resources and to closely interact with the campus community. You can contact the University Police Department at 292-2121.

In addition, a variety of student affairs offices sponsor special safety and rape education and prevention programs throughout the year.

Safety is a very personal matter, one about which you should be informed. Safety involves your physical health and well being, as well as the security of your surroundings and personal possessions. It requires that you not only be aware of preventive measures but also understand ways that you can effectively react should you be caught in a potentially hazardous situation.

In the final analysis, Ohio State is as safe as you make it. Crime prevention is everyone's responsibility. Here are some suggestions for improving personal security for both women and men students.

### **BASIC SECURITY MEASURES**

- Doors to your room or apartment should be locked at all times, whether you are at home or away.
- You should always look outside before responding to a knock on the door. Small windows and peepholes allow for this.
- Never let strangers into your room or apartment. Many homes are sized up by individuals entering on the pretense of selling merchandise, needing to use the phone, or wanting to look at the room or apartment.
- Don't leave notes on your door when away. If you lose keys, or move into a new room, change the lock.
- Beware of service or repair persons and remember to ask for identification. Don't isolate yourself in your room or apartment with the repair person.
- Keep your blinds and curtains closed at night.
- Always have your key ready when approaching your car, room, residence hall, or apartment.
- When walking at night, avoid dark alleys and shortcuts through deserted areas of campus or other poorly lighted areas. *Remember, the shortest distance isn't always the safest.*
- If you're followed on foot, cross the street, or change direction, vary your pace. If pursuer continues – go to a lighted area and call the police. (Use an Emergency Phone if one is in the area).
- Be prepared and alert.
- Learn self defense techniques.
- Mace and knives can easily be taken away and used against you. Therefore, it's better not to carry a weapon unless you've been trained to handle weapons. It's also likely to be illegal, and University Police recommend strongly against it.
- Notify friends when you are traveling around campus alone at low traffic hours. Tell them where you are going and when they can expect you to return.
- Park in well lit areas.
- Look inside your car, especially in the back seat, before entering.
- Drive with your doors locked and, whenever possible, with the windows rolled up.

- Drive on well traveled streets.
- Stay in your car with the doors locked if followed home. Sound your horn or blink lights for help.
- If you have car trouble, put the hood up, then stay in your car with doors locked and windows up and wait for help.
- Know where Emergency Phones are located. The phones are constantly monitored by University Police. Just knock-ing the phone off the hook alerts them, and officers are dispatched to that area immediately.
- Guard yourself in casual social contacts by involving oth-ers, and *terminate if not sure*.

### SECURE YOUR BELONGINGS

- Don't leave personal objects (wallet, purse, books) un-guarded in academic buildings, recreational facilities, or residence halls.
- Be sure to register your bike. You can do this free with University Police or the Division of Traffic and Parking, or at the Office of Off-Campus Student Services. Park your bike in a well lit area and secure to a rack. Use a pad-lock with a 3/8" case hardened shackle and comparable chain or cable.
- Engrave or otherwise mark your personal belongings with your name and maintain a list in-cluding any serial numbers. You can obtain engravers at your residence hall desk or at the Office of Off-Campus Student Services.
- Fasten all security devices. Locks are worthless unless they are used. This includes bicycle locks and locks on car doors.
- Don't give out duplicate keys except to people you can absolutely trust. Don't leave keys outside, under doormats, or in the mailbox.
- Don't leave property visible in your car.
- Lock your doors and trunk when parking.
- Report stolen articles fast, in as much descriptive detail as possible. An inventory such as that available through Op-eration ID is helpful here (available through residence halls, University Police, and the Office of Off-Campus Student Services).
- Be wary of letting persons stay with you that you really don't know.
- Keep in mind that door to door solicitations on campus may or may not be legitimate.

This is a service provided by the Ohio State University Police Department. You can be escorted to your car or dorm room at night. The hours of operation are: Autumn, Spring and Summer Quarters - 7:30 p.m. to 2:40 a.m., Winter Quarter - 6:30 p.m. to 2:40 a.m. For an escort you can call 292-3322 or visit the University Public Safety website at [http://www.ps.ohio-state.edu/sss/escort\\_info/](http://www.ps.ohio-state.edu/sss/escort_info/) .

### WHAT IF SOMETHING HAPPENS?

Obviously you can't always prevent things from threaten-ing your security. Should you become involved in a threat-ening situation, call the police, try to remain as calm as pos-sible, and take note of as much information about the situation as you can. Your first and only concern should be for your personal safety. Once you are out of the situation, seek help immediately. Emergency telephones are located in various locations on campus. In addition, you may want to carry a list of emergency phone numbers. Call 911 for emergencies and 292-2121 for non-emergencies.

- If you are threatened or cornered, yell or call for help.
- Run toward light and other people. It's better to be embarrassed if it's a false alarm than victimized if it's not.
- If restrained or threatened with immediate harm, give up property without resistance, but report immediately and assist in an apprehension, for the sake of future victims.

A limited number of university owned one and two bedroom apartments are available in Buckeye Village, located approximately one mile from central campus. Apartments at Buckeye Village include four accessible one bedroom and four accessible two bedroom apartments for families with members who are physically disabled. Ohio State students who are married or have dependent children are eligible to apply for housing at Buckeye Village. ### **Graduate, Professional and Nontraditional Housing**

There are two residence halls for students enrolled in graduate and professional schools and for nontraditional under-graduate students. These residence halls, Jones Tower and the Neil Building, offer the convenience of living on campus near classroom buildings, laboratories, and libraries.

Jones Tower, located on north campus, houses 470 men and women in single rooms. The Neil Building, located at the corner of Neil and 10<sup>th</sup> Aves, houses single men and women, and features efficiency apartments, 2 bedroom apartments, and bedroom apartments. Each building's units are air-conditioned and carpeted and have computer connection capabilities to the internet and OSU's network.

Rooms are furnished with single beds, bookcase, chairs, and desk lamps. Public areas are equipped with coin operated laundry facilities and vending machines, computer lab, game area, and swimming pool. Microwave ovens and kitchenettes for preparing snacks are also available in the buildings.

Accommodations in graduate, professional, and nontraditional housing are leased for an original term of one academic quarter; thereafter, the lease may be renewed for successive terms of one academic quarter. Students interested in graduate, professional, and nontraditional housing should submit their applications as soon as possible, as housing offers are made on a first come, first served basis.

### **Living Off-Campus**

The majority of students attending Ohio State live off campus – four out of five to be more precise. Whether you live only two blocks away from campus or in another city, you are considered an off-campus student.

Living off-campus can present special opportunities as well as special challenges. The ability to obtain accurate information quickly is important to off-campus students who are often balancing a variety of demands. The Office of Off-Campus Students Services makes it a priority to be consumer friendly and to provide information on a wide number of topics. Off-Campus Student Services sees itself as a one stop information center where students can get information on housing, roommates, utilities (including heating assistance applications), long distance telephone services that will bill roommates separately, safety and security (including personal property or renters insurance applications), transportation (including campus, city, and state maps and bus schedules), community organizations, voter registration, and “ Help is On the Way “ cards (which encourage panhandlers to make use of community re-sources rather than asking students for money).

The Off-Campus Student Services staff focuses on customer service. If you have problems finding an answer to any question about OSU or living off-campus, stop by the Off-Campus Student Service office. If the

staff does not have the information you need at their fingertips, they will find it for you as quickly as possible. You will not be ignored or sent away without help.

The office is open from 8 a.m. to 6 p.m. during summer quarter and breaks. All students are welcome and are encouraged to stop by the office for free information and referrals. ### **Off-Campus Housing Listing Service**

Columbus area property owners provide information about their available rental units through the Office of Off-Campus Student Services. Registered property owners must have a lease on file that is in compliance with the criteria established by Off-Campus Student Services. Students can determine from the listings which apartments interest them, then obtain a copy of the lease that the property owner has on file. Students may also wish to consult with Off-Campus Student Services staff for information and tips on what to look for when searching for an apartment.

During winter and spring quarters, Housing Fairs are also offered, providing the opportunity for registered property owners to interact with students on an individual basis to help students decide where they want to live during the next school year.

Your magnetized student ID (Buck•I•D) will let you eat in any dining commons or participating eatery on campus, buy items from vending machines, use the washers and dryers, and make purchases at the Ohio State Bookstore without using cash or credit cards. As part of this new program, meal plans with more flexibility than ever are now offered. To open a Buck•I•D Account, go to the University ID/Card Services Office, 219 Lincoln Tower, or call 292-0400. To report a card lost or stolen, call 292-2121

#### ***Menus, Food Selections, and Service in the Dining Commons***

A wide selection of menu items is offered at each meal. With the exception of a few featured entrees, you may take un-limited servings. An express carry out meal service (Buck-eye Express) is available for breakfast and lunch, Monday-Friday.

#### ***Meals Plans and Cash Rates***

Contracting for a meal plan is economical and convenient for students living on campus and for many living in nearby apartments. For guests or others, occasional meals in the dining commons are available.

Five dining commons provide meal service. Breakfast, lunch, and dinner are offered on Monday through Friday. Brunch and dinner are offered on Saturday and Sunday. Meal hours are published by Residence and Dining Halls and are posted at each serving area with carry out available from Buckeye Express and Oxley's-On-The-Go.

If you're interested in buying a meal plan, call 292-8266, or come into the Housing Assignments Office, 850 Morrill Tower.

### *Special Services*

For students who are on meals plans, several special services are available.

- Sack Lunch/Dinner. Food Service will prepare lunch or dinner to go for students who have class schedules or work hours conflicting with meal time.
- Sick Tray Service. Food Service will prepare a light meal for students on a meals plan when they are ill.

### **Eating On Campus**

Whether you want to catch a quick bite or indulge in a full meal, Ohio State has a place for you. Where you choose to eat depends a lot on the kind of food you want. Do you want fast food? Or is a sit down meal what you had in mind? Are you interested in a quick snack or a regular meal in a cafeteria? Or do you simply need a soda and a quiet place to eat your brown bag lunch? All of these options can be accommodated on campus or in the university area.

The major facilities that provide food on campus are listed here. Hours will vary at the various facilities and during quarter breaks. Look for posted hours or call the facility directly.

#### **DRAKE UNION**

#### **DINING COMMONS**

Housing and Food Services offers you another option for eating on campus. Whether you live in a residence hall or off campus, the dining commons can provide you with several meal plans or with occasional meals at established rates per meal. Locations are at Baker and Kennedy Commons in the south area of campus; North Commons in the north area; and Morrill Commons in the Olentangy area.

If you are a commuter student and you like well-balanced meals rather than fast foods on the run, the dining commons may be your answer. You can get a taste of on-campus living this way and make new friends. For information on specific meals plans (they'll save you money), call the Campus Dining Services, 47 Curl Drive, Room 107, North Campus, 292-8380. If you have guests, your visitors may purchase meals on a cash basis or use your Buck ID and receive a discount.

East/West prepares pasta and stir fry dishes. Stone Hearth serves wood-fired pizzas, breadsticks and casseroles. Soup Spot and Fresh Greens includes a self serve salad bar and a variety of soups. The Grab 'n Go case offers pre-made sandwiches and salads for those in a hurry. The MarketPlace also features a variety of retail items, from fresh fruit to frozen dinners to cases of Powerade.

### **Vehicle Information Procedures**

Vehicles parked on the Ohio State campus must be registered annually unless the vehicles are parked in a pay facility (meter, garage). Vehicles can be registered and decals issued by mail or in person at the Division of Traffic and Parking, Room 160, Bevis Hall, West Campus (phone: 292-9341). Your OSU I.D. must be presented. Mail registration is strongly recommended. Student decals for use on regional campuses must be obtained at the business office of the regional campus. A decal application/vehicle registration card, included in the "Getting to and Around Campus" pamphlet, is mailed to students with their quarterly university fee assessments.

Two-wheeled motorized vehicles must be registered and parked in motorcycle surface lot spaces. New parking decals are honored beginning September 1. Student decals expire on the first day of classes the following autumn quarter.

## **PARKING DECALS**

### *Graduate Level*

Graduate and Professional commuter students are eligible to purchase central campus "C" hangtag decals. Graduate and Professional residence hall students are required to purchase overnight proximity "CP" decals. Professional students are also eligible to purchase west campus "WC" or decals. Graduate Associate students are eligible to purchase staff "BG" decals. Written proof of the associate-ship must be submitted with the staff decal application. Graduate Associate residence hall students requesting "B" parking are required to purchase overnight proximity "BP" decals.

### *Disability Decals*

A physician's recommendation is required. Permanent disability parking may be requested through the Office for Disability Services, 292-3307. Temporary disability parking may be requested through Traffic and Parking, 292-9800 or the Wilce Student Health Center, 292-2112. Disability decals are valid in general disability, and in surface and garage spaces, but not in license specific disability and state vehicle spaces.

### *Garage Decals*

Daytime garage decals are available to graduate and professional com-muter student through a lottery system. To participate, indicate a garage preference on the application card. Visit the transportation and parking website for more details. Evening garage decals are available to graduate and professional students at any time.

### *Car Pool Decals*

Carpooling is easy with the transferable parking permits. A parking permit can be displayed in any vehicle within the carpool as long as the registered person is along. If the carpool separate, individual permits can be issued.

### *Decal Replacements and Refunds*

Decal replacements and refunds can be made by mail or in person. Return the hangtag decal with your replacement request to Traffic and Parking. Without the hangtag, replacement is made at the prorated decal fee. Refunds are prorated quarterly and processed only upon return of the decal scrapings. *No* refunds are issued after the fourteenth day of spring quarter.

### *Parking Hours*

Between the hours of 5 a.m. and 2 a.m., central campus decals are valid in all campus "C" lots. West campus decals are valid only in west campus lots. Between the hours of 4 p.m. and 2 a.m., student decals are also valid in all nonrestricted "A," "B," or "C" surface spaces outside the gate controlled zone. An evening "EVE" permit may be added to park inside the gate controlled zone between 4 p.m. and 2 a.m. Call 292-9341 for details.

Between the hours of 8 p.m. and 2 a.m., students may also park on South Oval Drive, across from the Main Li-brary. Students working overnight on academic assignments may qualify for special overnight parking. For details, call 292-9341. Evening garage decals allow students to park in the Northwest, Arps, Ohio Union, 11th Avenue, and 9th Avenue garages from 4:00 p.m. until 2:00a.m.

### *Meter Parking*

Anyone can park in a metered space as long as the meter fee is paid. Meters are enforced 24 hours a day, 7 days a week.

### *Football Parking*

On football Saturdays, A, B, and C decal holders may park in any lot not designated at a Season Permit lot. Season permit lots are identified by signage state "No Parking After 5 a.m. on Football Saturdays, Tow Away Zone."

### *Enforcement*

Anyone not complying with Ohio State's Traffic and Park-ing regulations may be cited and required to pay the appropriate fine. Students with any unpaid citations will have a "Hold" placed on their records and may have their next quarter's registration and/or transcripts withheld. To release an impoundment or student hold, all outstanding fines (including towing charges) must be paid in full.

Signage posted at the surface lot entrances designates who may park in which section of the lot. "No Parking," "Tow Away," "No Parking/Stopping/Standing," and "Loading Zone" signs are strictly enforced.

Misuse of a decal and/or key card may result in fines up to \$150.

General and license specific disability parking spaces are reserved campus wide 24 hours a day, seven days a week. Violator vehicles will be towed.

Fines may be paid at the Division of Traffic and Parking, 160 Bevis Hall, West Campus, Monday - Friday between 7:30 a.m. and 7:30 p.m. and Saturday 12:00 p.m. to 5:00 p.m.

### *Appeals*

Citations may be appealed without prior payment if the appeal is filed within fifteen working days from the date of is-suance. After fifteen days, the right to appeal is forfeited. Appeal forms are available at the Traf-fic and Parking offices and at all locations issuing tempo-rary decals. Letters are accepted in place of the official ap-peat forms.

### *Bicycles*

We encourage you to register any bike brought to campus because, in the case of a loss or theft, the simple procedure can help to locate your bicycle. Bikes can be registered free of charge at the Transportation and Parking Service, 160 Bevis Hall or call 292-9341. You will be given a copy of the Traf-fic and Parking rules and regulation for campus cyclists when you register your bike.

Please park in designated areas. Locking your bike to any railing near entrances to ramps for the handicapped, stair-wells, fences, trees, and light poles can result in impound-ment. The university is not responsible for locks destroyed during the impoundment.

### **Temporary Permits**

If your registered vehicle is inoperable, you may obtain a temporary permit for another vehicle at no additional cost from one of the following locations. You are entitled to thirty free replacement days each decal year.

## **STUDENT HEALTH INSURANCE**

(<http://shi.osu.edu/>)

The University recognizes that good health is essential to a student's achieving his/her educational goals, and that access to adequate health care may be affected by one's ability to pay. Therefore, students are automatically insured for each school term in which they are enrolled. The premium is included in the student's fees. Students who are enrolled **at least half time** (6 eligible hours for undergraduate students and 5 eligible credit hours for graduate and professional students) and are attending any campus\* of The Ohio State University are eligible for coverage, as are their dependents.

**Exceptions** apply to enrolled students taking one of the approved exception course numbers representing **co-ops, internship, study abroad, and thesis or dissertation research**. These students will be automatically charged and the health insurance premium will be included in their fees, unless the student waives coverage.

### **Professional Students : Waiving Procedure**

**If you already have comparable health insurance coverage** (through a parent, spouse, employer, etc.) and do not wish to enroll in the Student Health Insurance Plan, you must submit an online waiver by the **15th day of your initial term of enrollment each academic year**.

**It is your responsibility to view your online Account Statement** at the beginning of each quarter to ensure that it reflects the appropriate level of Student Health Insurance coverage regardless of your college's or a University program's involvement in your registration process and/or who is paying your bill.

Please have a copy of your **health insurance card** with you before you begin the process.

- Go to [www.buckevelink.osu.edu](http://www.buckevelink.osu.edu).
- Click on "**Web Registration for Courses**".
- Enter your OSU **username/password** and click "**Login**".
- Use the drop-down menu to select the **correct Quarter and Year**, and then click "**Continue**".
- Scroll down until you see the "**Fee Options**" heading. The first line under "Fee Options" will say "**Elect/Waive Insurance Coverage.**"

- Change the selection in the drop-down box from "Comprehensive" to "**No coverage**", then click "**Update Fee Options**".
  - **NOTE:** YOU MUST CLICK "UPDATE FEE OPTIONS". Going straight to "Adjust Schedule" will NOT accept the changes that you have just made.
  - **NOTE:** IF THE DROP-DOWN BOX ALREADY INDICATES "NO COVERAGE", you may have already submitted your waiver for this year. View your online Account Statement to verify that "Comprehensive Insurance" does not appear as a line item on your bill.
  - **NOTE:** IF THE DROP-DOWN BOX INDICATES "WILCECARE", you have already waived Comprehensive Student Health Insurance and have selected the WilceCare Supplemental option on the waiver form. If you no longer want WilceCare coverage, please contact the Student Health Insurance Office via your OSU email account prior to the 15<sup>th</sup> day deadline to request that it be removed from your account.
- Verify that your "Student Information" is correct, read the "Insurance Overview" and "Issues to Consider" and then click "**Next**".
- At the top of the "Waiver Form" page, **mark the appropriate circle** to indicate whether you would like to purchase the WilceCare Supplement. (WilceCare supplements your existing health insurance and can only be used at the Wilce Student Health Center.)
- Fill in your "**Insurance Company Information**". Complete this section as completely and accurately as possible, and then click "Next".
- Read the acknowledgement page and click "**I Agree**".
- Print or write down your **confirmation number**. (The process is not complete until you have received your confirmation number.)
- Confirm that you have successfully waived your Student Health Insurance by viewing your online **Account Statement** at [www.treasurer.ohio-state.edu](http://www.treasurer.ohio-state.edu) and verifying that there is no longer a line item charge for "Comprehensive Insurance".

### **Student Health Services**

The Wilce Student Health Center (Student Health Services) at The Ohio State University is a JCAHO accredited, outpatient facility providing a variety of health care services to the student population. All students enrolled at OSU are eligible to use the health service, regardless of health insurance coverage.

Student Health Services provides most services on an appointment basis. However, injuries or illness that requires immediate attention may be evaluated by one of our Advice Nurses and scheduled to see a physician on a same day basis. Students may schedule an appointment in any of our Service areas by contacting the Appointment Desk on the first floor of the health center or calling 292-4321 during business hours. When you are unable to keep a scheduled appointment, please contact the Appointment Desk any time of day or night to cancel. This will allow us to provide another student with that appointment time. Appointments not cancelled at least two hours prior to the scheduled appointment time may result in a no show fee.

Fees are assessed for office visits, medical procedures, dental services, ancillary services, prescriptions and supplies. The Wilce Student Health Center is partially funded with student fee dollars. These fee dollars help to keep the medical services at the Student Health Center among the most affordable in the Columbus area. Questions regarding fees should be directed to the Patient Relations Office. Usually, but not always, these charges are covered under the OSU Student Health Insurance Plan or the Wilce Care Supplemental Insurance Plan. Students who are insured under one of the OSU Student Health Insurance Plans will have their claims automatically processed according to their plan benefits. Claim submission to other 3rd party health insurance plans is also available upon request. Our pharmacy accepts most prescription drug programs. Cash, check, BuckID, Visa, Mastercard, or Discover/Novus are accepted for payment of co-pays, co-insurance, deductibles or non-covered services.

### *Where Is the Health Center?*

The Health Center is located near the center of campus, between the Townshend Hall and RPAC. The address is 1875 Millikin Road, Columbus, OH 43210-2200.

### *When Is the Center Open??*

Standard hours are Monday - Friday 8:00 a.m. to 4:30 p.m. These hours are subject to change, please call 292-2112 for more information.

After hours or on weekends, if you have an urgent care need, you should go to one of the Columbus area MedOhio facilities or the University Hospitals Emergency Room. You are advised that services provided by the MedOhio facility or University Hospitals are not governed by the same schedule of fees as the Student Health Service. Student Health Insurance may defray a portion of the cost.

### *How to Use the Health Center*

All clinics (except for Urgent Care) prefer that you make an appointment before you come in. To schedule an appointment, call 292-1321. Plan to arrive 15 minutes before your scheduled appointment. Allow at least one hour for your appointment and additional time if a stop at the pharmacy is needed. Be sure to take your Ohio State ID with you. If you have an appointment, go directly to the clinic. For urgent care, or consultation regarding your health needs, report to the Advice Nurse in the main lobby.

The office visit fee will be waived if you are a currently enrolled student. You will be responsible for charges associated with dental exams, laboratory work, x-rays, physical therapy, pharmaceuticals, supplies, vision exams, and medical and dental procedures performed. Be sure to ask in advance what the charges will be if that is a concern.

The doctor may refer you to another clinic or support service. Be sure you understand what the doctor expects you to do. If charges are incurred, your last stop will be the business office. If you do not have student health insurance or incurred charges not covered by the policy, you are expected to pay at the time of service.

### *Urgent Care*

Injuries or conditions that may require immediate attention are treated in Urgent Care on a walk-in basis. You do not need an appointment.

If you are not sure whether you need medical or surgical service, or whether you need an appointment, call 292-4321 or come in to talk with one of the advice nurses at the Health Center.

### *Advice Nurse*

Your initial contact with the Wilce Student Health Center Staff may be with an Advice Nurse (1st floor lobby area). Our Advice Nurses can answer health related questions, provide health counseling, assess health needs and make referrals to appropriate services.

If you have an injury or condition requiring immediate attention, you may be seen on a same-day basis by our on-call physician. Students with more serious problems will be seen ahead of those with less serious problems. The Advice Nurse makes all referrals to this service.

### *Preventive Medicine*

The Preventive Medicine Program is designed to protect the health of students in general, and in particular, those students participating in programs that place them at increased health risks. Services include immunizations for students in special programs, tuberculosis screening, preventive therapy for international students, immunizations and health education for students traveling abroad, and control of communicable disease among the entire Ohio State student population.

### *Women's Services*

Women's Services (2nd Floor) at the Wilce Student Health Center offers annual gynecologic exams, diagnosis and treatment of gynecological disorders, pregnancy testing and birth control.

Diagnosis of urgent dental problems and consultation for any oral problems is provided in our Dental Services area (2nd Floor). You can also make an appointment to have your teeth cleaned, examined and x-rayed.

Optometry Services (2nd floor) offers students comprehensive eye examinations, treatment and management of ocular diseases, trauma services, and refractive surgery consultation.

The Eye Wear Gallery has a large selection of stylish affordable frames and the most advanced technology in spectacle lenses available to meet your needs. The Gallery also offers several types of contact lenses from disposable to custom and conventional lenses. Frame repairs and adjustments are done on a walk-in basis.

Specialty Services (3rd Floor) offers a variety of services to students by appointment. Our services include:

Allergy Services: Offers evaluation and testing.

Injection Therapy: Provides allergy shots and other injections.

Internal Medicine: Deals with patients with multiple illnesses and/or complex medical problems requiring long term follow-up.

Sports Medicine: Staffed by physicians specially trained to evaluate, treat, and rehabilitate students injured at all levels of sports activities, from the varsity player to the weekend athlete.

Dietitian Services: A licensed Dietitian is available to provide counseling and instructions for special diets and weight management.

(1st Floor) Implements multifaceted approaches to address the health related needs and concerns of college students through awareness, education, and prevention. ## **OSU MEDICAL CENTER**

### **CLINICS**

Students who are ill can receive health care several places on campus. Health Center services are designed with the student needs in mind. After Health-Center hours or for special services not available at the Center, students may call Ask-A-Nurse at 293-5678 for help in directing them to one of the many Ohio State clinics on campus. These include the University Hospitals Emergency Department, University Hospitals Clinic, Dental Clinic, Dental Hygiene Clinic, Speech-Language-Hearing Clinic, and the Optometry Clinics.

### *University Hospitals Emergency Department, 450 West 10th Avenue 293-8333*

University Hospitals Emergency Department is a fully equipped and staffed facility offering comprehensive emergency care. The Emergency Department is open 24 hours per day, 365 days per year, and is staffed with nurses and physicians who are specially trained in emergency medicine.

Walk-in care is available without appointment. Patients are seen according to the severity of their illness or injury – not on a first-come, first-served basis. Emergency department fees are billed to the patient or

insurance company after the visit. Students should bring their health insurance information with them when seeking emergency care.

*University Hospitals Clinic, 456 W. 10th Avenue*

*293-8005*

The University Hospitals Clinic (UHC) offers services in 45 specialty areas where outpatients visit with physicians and undergo outpatient procedures and testing. The clinic is open for scheduled appointments from 8 a.m.-5 p.m. weekdays with some areas offering evening and/or Saturday hours.

The clinic offers a pharmacy conveniently located within the building for patient's use. Pharmacy hours are 8 a.m. to 6 p.m. weekdays.

Clinic fees can be paid by VISA, MasterCard, check, cash, money order, or American Express. In order to use the outpatient benefit of the student health insurance plan you must be referred to the University Hospitals Clinic by a physician at the Student Health Center. Visit the business office of the clinic before you file your insurance claim to make certain all professional and institutional fees can be processed.

*Dental Services, 305 West 12th Avenue*

*292-2751*

Comprehensive dental and oral health care is available at this clinic. Hours are: 8:30a.m.- 11:30a.m. and 1:00-4:00p.m. weekdays, except Wednesday when hours are 9:30p.m.-11:30a.m. and 1:00p.m.-4:00p.m. Appointments are necessary, and they last from one to three hours depending on treatment provided. Walk-in emergency care is available during the first hour of each clinical period.

Payment for each visit must be made before the treatment begins. VISA, MasterCard, check, cash, and money orders are accepted. Student Health Insurance Plan dental benefits are accepted when applicable.

*Dental Hygiene Services, 305 West 12th Avenue*

*292-2751*

This clinic offers dental hygiene assessments, X-rays, teeth cleaning, fluoride treatments, and dental sealants. Hours are 8:30 to 11:30a.m. and from 1:00 to 4:00p.m., Monday, Tuesday, Thursday, Friday, and Wednesday hours are 9:30- to 11:30a.m., and 1:00 to 4:00p.m.

To make an appointment, call 292-2222 during business hours. Payment may be made by VISA, MasterCard, check, cash, or money order and must be made prior to examination. All other dental work is done by the University's Dental Clinic.

*Speech-Language-Hearing Clinic, 1070 Carmack Road 292-6251 (voice or TDD)*

The clinic provides brief screening tests, comprehensive evaluations, consultations, and treatment of speech, language, and hearing problems. Appointments are necessary and can be scheduled by calling the clinic between 8 a.m.-5 p.m., Monday through Friday.

Screenings are free for students. Cash, check, VISA, or MasterCard are accepted for all other services.

*Optometry Services, 338 West 10th Avenue*

The Optometry Clinic provides total vision care. The clinic is open Monday through Friday from 8 a.m.-5 p.m. and Tuesday and Thursday 8:00 a.m. to 7:00 p.m. Appointments are necessary. A fashion, sports, and safety eyewear dispensary is located in the clinic. Cash, VISA, MasterCard, check, money order, and some insurance are accepted for payment. Special services include contact lenses, low vision, geriatric, pediatric, and vision training clinics. Computer departments are set up in the Main and Medical bookstores on the Columbus campus. Regional campus customers should check with their bookstore manager for information.

#### **Q: Do the University Bookstores accept credit cards?**

A: Yes. MasterCard and VISA are accepted at all locations. We also accept the Discover card and American Express on the Columbus campus. The Main bookstore also accepts Barnes and Noble gift cards.

#### **Q: Does the University Bookstores accept the Buck •I•D?**

A: Yes. The University Buck•I•D debit card is a very convenient way for you to purchase your books, supplies, and other items at the University Bookstores.

#### **Q: May I write checks at the University Bookstores?**

A: Yes. You may write a check for your purchases with your University ID and one additional piece of identification. Personal checks up to \$10 may also be cashed for a \$.25 fee. For added convenience, an automatic teller machine is located in the main bookstore upper foyer.

#### **Q: What if a book is stolen?**

A: If someone steals your book, report it to the University Police Department. To identify your books, write your name on a particular page in the center of the book.

**Q: How about selling used books back? When is the best time to do this? How much money will I get?**

A: The University Bookstores buy books back everyday. How much you will get depends on whether or not it will be needed the next quarter. Our Buyback pricing is based on 2 criteria: we can pay you 50% of the selling price if the professor has told us the book will be used again the following term and we still require more to meet demand. If this is not the case, we will be happy to give you the latest national pricing.

OIT manages many Student Computer Centers across campus to ensure that students have access to technologies for course work that requires current computer hardware and software and Internet access. The sites are equipped with Windows and/or Macintosh computers and a variety of peripheral equipment. Software includes word processing, desktop publishing, spreadsheet, e-mail, Web browsers, and others. Faculty can schedule classes in most centers, so students should check the schedule each week for availability. Ohio State's Internet services are available to all students, faculty, and staff through direct, wired connections in campus offices, departmental computing labs, Student Computer Centers, and residence halls. #### *Ohio State Options*

- ResNet is a direct high-speed Internet connection for each student in every residence hall. The service is among the fastest available and does not tie up personal phone lines; it requires installation of an ethernet card. The Department of Housing, Food Services and Events Centers supports ResNet. - OSUWEB.net is a fee/subscription-based dialup offering from UNITS. OSU students, staff and faculty pay \$6.95 per month for up to 100 hours of connectivity (additional time billed at \$0.10 hour), five

megabytes of personal web space, and about 97-percent first-time dialup connectivity. Customers also retain osu.edu e-mail service. Visit <http://www.osuweb.net/>.

- HomeNet is an OIT baseline service that provides off-campus, dial-in modem access for faculty, staff, and students. Dial 722-9800 for a 30-minute connection or 722-9900 for a 6-hour connection (fewer lines available). HomeNet has limited availability.

### *Commercial Options*

- Road Runner cable modem service is a high-speed online service delivered to your desktop computer via Time Warner cable's hybrid fiber-coaxial network. It does not tie up your phone line and you are instantly connected without encountering dial-up busy signals that are typical of any phone-modem based services. Road Runner is also available to customers using Insight or WOW cable.
- DSL technology provided by local phone companies generally offers faster connection speeds than modems but requires interface cards and special phone lines. Speeds depend on the distance between your residence and the phone company's equipment.

The libraries on the Ohio State University Columbus Campus – University Libraries and the Law and Health Sciences Libraries – have a combined collection size of nearly 5.2 million volumes and regularly receive approximately 36,000 serial titles.

University Libraries consists of the Main Library and a number of department libraries and other specialized collections. University Libraries is also a member of OhioLINK, a statewide library and information network linking the major academic and community college libraries in Ohio, plus the State Library. The Main Library provides materials and services related to the humanities and social and political sciences. The collection includes major reference materials, government documents and some special collections. At our newly renovated main library, students also can check out and pick up books that are directly housed in the Columbus Public Library.

Recreational sport is a vital component of the total educational process at The Ohio State University. The informal relationships that are established through involvement in sport often times become an integral part of a student's life.

The Department of University Recreation and Intramural Sports cordially invites you to become an active participant in one or more of the various forms of leisure-time activities available to you as a member of the university community.

### **Intramural Sports**

Intramural sports provide every student the opportunity for competitive participation in a vast number of team, dual, and individual sports. Programs are organized to provide students of all skill levels the challenge of competing against others of comparable ability. This is accomplished through the voluntary classification of participants into skill divisions when entering a tournament.

No individual is denied involvement for lack of team affiliation. Although most students do sign up as members of a team, everyone interested in an activity is encouraged to register. Individuals are placed on teams so they, too, may experience the camaraderie associated with group competition.

In addition to those tournaments held exclusively for men and women, Ohio State offers an extensive co-rec intramural sports program, where men and women combine their interest in sports by forming teams and competing in a variety of activities. The co-rec program affords Ohio State students the opportunity for intramural involvement in an atmosphere emphasizing the social rather than the competitive aspect of sports.

New tournaments are sponsored each quarter. For a complete list of available activities and registration dates, please refer to the University Recreation and Intramural Sports Handbook.

There is no cost for participating in any tournament except team sports. The only requirements are current Ohio State ID card and fees paid in full.

### **Sport Clubs**

The Sport Clubs program is concerned with the support and guidance of special recreational interest groups on campus. It currently consists of 75 organizations which provide unique competitive, recreational, and instructional opportunities apart from those sponsored by Intramural Sports or Varsity Athletics.

Clubs exist on the interest and quality of student leadership. Club members make the decisions concerning practices, schedules, budgets, coaching, and social events. Club sport is viewed as an experience that blends the commonality of interest with the joy of competition within a socially oriented environment.

### **Informal Recreation**

The informal recreation program offers students, faculty, staff, and their immediate families opportunities in self-directed recreational pursuits. The various recreational opportunities that are available to the university community include: swimming, jogging, fitness programs, conditioning, basketball, volleyball, table tennis, handball, racquetball, and tennis.

Ohio State proudly offers its community one of the finest selections of recreational complexes and outdoor facilities in the country. All activity areas are available to the campus community. Students are automatically members and a mandatory recreation fee of \$78 is applied to your fee statement each quarter.

The Jesse Owens Recreation Centers North and South house volleyball, basketball, and tennis courts. They are located in close proximity to residence halls. The Jesse Owens Recreation Center West houses four tennis courts and various outdoor activity sites. The main activity center, Recreation and Physical Activity Center (RPAC), is centrally located on the campus for easy access by a majority of university people. The Adventure Recreation Center (ARC) is located on west campus and features courts, turf fields, weights,

strength training and cardio equipment as well as a 4,000 square foot, 35 foot tall climbing wall and outdoor equipment rental office.

Reservation systems for securing activity space have been designed for the convenience of the participants and provide for maximum use of each area.

## **Athletics**

Students are urged to support Buckeye sports teams by attending athletic events whenever possible. Reduced rate tickets are available to students for football and men's and women's basketball; men's ice hockey, wrestling, men's and women's volleyball, men's and women's gymnastics, men's and women's soccer, and baseball. All other sporting events are free of charge.

## **Variety of Sports**

There are eight varsity sports during the autumn quarter – football, cross country, golf, tennis, and soccer for men; cross country, field hockey, soccer, tennis, volleyball, and golf for women.

Winter quarter is the busiest quarter in terms of number of teams competing. That number now stands at seventeen, nine for men and eight for women. Men compete in basket-ball, fencing, gymnastics, ice hockey, track, swimming and diving, and wrestling, while women compete in basketball, fencing, gymnastics, synchronized swimming, swimming, and track. Pistol and rifle competition is coed.

In the spring, students can choose from baseball, golf, lacrosse, tennis, track, and volleyball for men; and golf, soft-ball, tennis, and track for women.

Both the men's and women's teams play challenging schedules, meeting teams from around Ohio, the Midwest, and the nation. Most of the men's and women's teams compete in the Big Ten and play an extensive schedule of games with Big Ten foes that is complemented by games with other national powers.

The men's hockey team plays in the extremely competitive Central Collegiate Hockey Association. The lacrosse team competes in the Midwest Lacrosse Association, while the Men's volleyball squad plays in the Midwest Intercollegiate Volleyball Association.

## **Facilities and Guest Privileges**

As a university affiliate, you may sponsor any number of guests per day. The charge is \$10.00 per day for each guest (or at a discount for multiple days). This entitles your guest(s), when accompanied by you, to full use of all recreational facilities and most open recreation programs on campus for one calendar day. Guest passes may be purchased in the Recreation and Intramural Sports Office, at RPAC, any time that the building is open. The guest must have a photo I.D. and cannot borrow equipment.

There is probably a greater variety of recreational activities to be found in this one building than in any other campus building in the world. No running shoes are permitted in the gymnasiums. Bring your Ohio State ID card.

### *Using a Locker*

For the safety of your personal belongings, you'll probably want to take a combination lock to protect your things in a locker. There are many open (unlocked) lockers available in the locker rooms. Choose from any that are not being used.

### *Swimming*

- Check schedules to see which pool is designated for open recreation.
- Lock clothes and valuables in locker; shower before entering pool.
- Give ID to lifeguard and swim as long as you wish. Pick up ID when you finish.
- Kick-boards and pull-buoys may be checked out from the 50-meter pool.

### *Handball, Squash, Racquetball*

- To reserve a court, call 292-8590 after 6 p.m. on the day before you wish to play.
- Arrive 10 minutes before your scheduled playing time.
- Leave ID at Activity Reservations desk to confirm your reservation and pick up needed equipment

### *Conditioning Rooms and Nautilus Weight Room*

- Change clothes and keep ID with you.
- Give ID to conditioning room attendant who will give you a pin when one is available.
- Keep the same pin for entire workout (time limit enforced), then return it for your ID before leaving.
- No clothing with zippers or personal items are permitted in the workout facilities.

### *Basketball, Table Tennis, Volleyball, Football, Softball, Platform Tennis, and Baseball*

- Dress in sportswear beforehand if necessary.
- Check out equipment with ID from first-floor activity reservations desk.
- Return equipment for your ID when finished.
- No running shoes or shoes suspected of marking floors are permitted.

### *Jogging*

- Change clothes; leave ID in locker.
- Enter jogging track from stairway on second floor hall.

### *Fitness Programs*

- Low-impact aerobics, combination (low-impact and high-intensity combined), strength/endurance training, step express workouts.
- Give ID to door attendant.
- Lock clothes in locker.
- No running shoes, or shoes suspected of marking the floors, or personal items are permitted.

## **SEXUAL HARASSMENT POLICY**

The University administration, faculty, staff, and students are responsible for assuring that the University maintains an environment for work and study free from sexual harassment. Sexual harassment is unlawful and impedes the realization of the university's mission of distinction in education, scholarship, and service. Sexual harassment violates the dignity of individuals and will not be tolerated. The university community seeks to eliminate sexual harassment through education and by encouraging faculty, staff, and students to report concerns or complaints. Prompt corrective measures will be taken to stop sexual harassment whenever it occurs.

### **DEFINITION**

Sexual harassment is any unwelcome sexual advance, request for sexual favor, reference to gender or sexual orientation, or other physical or verbal conduct of a sexual nature when: (1.) Submission to, or rejection

of, such conduct is used either explicitly or implicitly as a basis for any decision affecting terms or conditions of an individual's employment, participation in any program or activity, or status in an academic course; or (2.) Such conduct has the effect of unreasonably interfering with an individual's work performance or education, or creates an intimidating, hostile or offensive environment for working, learning, or living on campus, and has no legitimate relationship to the subject matter of a course. The university has also instituted a new policy regarding consensual sexual relationships. Please see the complete file for details, but realize that the following are prohibited:

- Teachers (faculty, instructors, staff, Gas, undergraduate TAs) are prohibited from engaging in romantic and/or sexual relationships with students in their classes.
- Faculty, staff or instructors as well as faculty from other universities or individuals from industry are prohibited from engaging in romantic and/or sexual relationships with students upon whose thesis, dissertation, program or candidacy exam committees they sit; or over whom they exercise significant academic or career determining authority.
- Faculty, staff, instructors, graduate students, undergraduate students and volunteers are prohibited from engaging in romantic and/or sexual relationships with any individual as defined in their field-specific codes of ethics or professional responsibility.
- Supervisors (faculty, staff, student) are prohibited from engaging in romantic or sexual relationships with employees they supervise (direct reports).

#### **MINORITY AFFAIRS**

The Office of Minority Affairs (OMA) is a long established vehicle of the University, with specific mandate to recruit minority students since 1970. Its model suggests a 5-pronged effort of building: 1) early intervention, 2) recruitment, 3) retention, 4) release with a degree, and 5) post-baccalaureate activities. While excellence in service and programming remains its top priority, "Unity With Diversity" speaks of its direction.

OMA continues to serve as a clearinghouse; referral service; liaison among administration, academic units, students, and the community; and as an adviser to students and administration.

OMA Special Programs also include on-going minority graduate and professional recruitment activities. In collaboration with the Graduate School, professional colleges, and other academic units, Graduate and Professional Schools Visitation Days began in 1971 as a means to increase the pool of minority students pursuing graduate and professional degrees at the university. To date, over 1,600 minority honor students have been recipients of fellowship awards through the Graduate School and the graduation rate remains at about 80%.

Other OMA functions include undergraduate and post-baccalaureate orientations, a faculty colloquy, the Minority Scholars Retreat, Academic Leadership and Service Recognition, and these important areas:

- The University Mentoring Program provides first-year African-American students with a peer mentor (upper class student) and a professional mentor (a university faculty or staff member) and assists in developing peer-mentor relationships for Hispanic-American students in order to support and nurture their personal and intellectual development.
- The ACCESS Program offers peer support for minority single parents who face the challenge of being a student, parent, and head-of-household.
- The Young Scholars Program is designed to improve the academic skills of selected 6th-12th graders, preparing them for entry into Ohio State upon completion of high school.
- The Student Achievement in Research and Scholarships (STARS) program helps African-American, Hispanic-American, and Native -American undergraduates enroll in Ohio graduate and professional schools by offering faculty members and a state-wide STARS clearinghouse.

- The annual OMA Job Fair features about 100 companies who interview seniors, graduate, and professional students for possible job placement.
- The Frank W. Hale, Jr. Black Cultural Center provides many programs and services designed especially for minority students. It also serves as a resource center for the entire campus community on African-American issues regarding race and diversity, and their various contributions to the world of arts, letters, and sciences.

OMA also sponsors or cosponsors a range of academic and culturally -specific social-activities throughout the year.

It is the duty of each University office, faculty, staff member, and student to carry out her/his responsibilities and conduct themselves in such a manner as to achieve these goals. Only through the affirmative efforts of all faculty, administrators, staff, and students will such a community be realized.

The University's Office of Human Resources/Affirmative Action, 113 Archer House, 2130 Neil Avenue, phone 292--4164, is the university's principal resource office for affirmative action compliance. The office is responsible for the coordination of matters relating to affirmative action and equal opportunity.

### ***THE DISTINGUISHED AFFIRMATIVE ACTION AWARDS***

This important recognition program was established in 1982. These awards are given annually to individuals or units that have significantly advanced affirmative action at The Ohio State University. The recipients are selected by the University Senate Committee on Women and Minorities from nominations made by the campus community, including our alumni. The persons or units honored receive a plaque and a monetary award. Nominations are made in January and the award recipients are announced in May of each year. Student and student organization nominations are encouraged.

### ***NONDISCRIMINATION/AFFIRMATIVE ACTION POLICY***

The policy of The Ohio State University, both traditionally and currently, is that discrimination against any individual for reasons of race, color, creed, national origin, religion, sex, sexual orientation, age, disability, or Vietnam-era veteran status is specifically prohibited. Accordingly, equal access to employment opportunities, admissions, educational programs, and all other university activities is extended to all persons, and the University promotes equal opportunity through a positive and continuing affirmative action program. The University's Office of Human Resources/Affirmative Action, 124 Archer House, 2130 Neil Avenue, Columbus, Ohio 43210, phone 292-8993, is responsible for the coordination of matters relating to equal opportunity and affirmative action.

The United States Department of Defense policy which excludes gay, lesbian, and bisexual students from full participation in Reserve Officer Training Corps programs is in violation of University Policy Number 1.10 (Revised 1/31/85) which provides that no person can be discriminated against on the basis of sexual orientation. However, substitute Senate Bill Number 249 enacted by the Ohio General Assembly effective 1992 provides in part "(B) No board of trustees of a state university shall remove from the curriculum, its campus, or any facility of the university any armed forces training unit or class unless the removal is the result of a reduction in such units or classes by the United States Department of Defense."

## **NO SMOKING POLICY**

The University recognizes the need to create and maintain an environmental quality that sustains and enhances the general health and well-being of its faculty, staff, students, and visitors. In order to meet this commitment, no smoking will be permitted in any of the indoor areas as designated in the guidelines. Consistent with the spirit and intent of this policy, should irreconcilable conflicts arise between individuals who choose to smoke and those who do not, the rights of nonsmokers will prevail.

### ***POLICY GUIDELINES***

OSU Medical Center has instituted a ban on smoking. The ban on all smoking and tobacco products includes all indoor and outdoor locations and parking areas on the main medical center campus, at University Hospital East and all other OSU Medical Center-owned primary care sites and properties around central Ohio.

A. Smoking will not be permitted in any indoor areas including, but not limited to, the following: classrooms, auditoriums/conference rooms, laboratories, elevators, theaters, word processing/computer areas, copier rooms, mail rooms, reception areas, open office areas, libraries, University Hospitals, areas in which fire and safety hazards exist, cafeterias, administrative offices, hallways, lobbies, lounges, private offices, restrooms, stairwells, university vehicles, waiting rooms, and workshops.

B. The only exception to this policy is specifically designated private residential space within university residence halls, apartments, hotels, and university leased residential facilities. Any interior areas authorized for smoking must be so designated. Areas that are designated as smoking areas will be clearly marked with "Smoking Permitted" signs.

C. Smoking is permitted outdoors, except in outdoor facilities such as stadiums, including concessions areas, amphitheaters, and other locations of fixed seating. Smokers who choose to smoke outside are requested not to smoke near building entrances and to ensure the proper disposal of smoking materials.

D. University groups who schedule outdoor spaces for approved functions, other than facilities covered in C above, have the authority to designate such functions "Nonsmoking or Smoking" as they may desire, consistent with the intent of this policy.

## TOP SITES BEYOND DOWNTOWN

**Park of Roses**, 3929 N. High Street in Whetstone Park. The Columbus Park of Roses is a unique 13 acre garden setting within a park featuring over 11,000 rose bushes and specialized gardens such as the Herb Garden, Daffodil Garden, Perennial Garden and specialized collections of miniature and heritage roses. The Park of Roses is conveniently located off North High Street in the heart of Whetstone Park and is open and free to the public. It is one of the largest municipal rose gardens in the United States.

**Franklin Park Conservatory**, 1777 E. Broad Street, Bexley, 645-3000. Built in 1895, Franklin Park Conservatory is a botanical landmark two miles east of downtown Columbus. It is a premier horticultural and educational institution showcasing exotic plant collections, special exhibitions, and a signature collection of work by glass artist Dale Chihuly.

Set within the 88 acres of Franklin Park, the Conservatory houses 400 species of plants from a variety of global climate zones and features a Victorian Palm House with more than 40 species of palms. It is surrounded by botanical gardens and floral displays.

**Columbus Zoo and Aquarium**, Powell, 645-3400. Home to rare animals, former zoo director Jack Hanna, and great seasonal events like Wildlight Wonderland in December and the summer music series.

**Jack Nicklaus Museum**, 2355 Olentangy River Rd 247-5959. Located on the OSU campus. Educational facility honoring Jack Nicklaus and golf's history.

**Ohio Craft Museum**, 1665 W. Fifth Avenue, Grandview Heights, 43212, 486-4402. Located in Grandview Heights. The Ohio Craft Museum is a program of Ohio Designer Craftsmen which presents five major exhibitions each year, as well as focus exhibits and a rotating display of the permanent collection. In addition, the museum houses the Craft Research Library and stages educational workshops and events for all ages and levels of experience. Ongoing funding for the museum is provided by the Ohio Arts Council, Greater Columbus Arts Council, and the Columbus Foundation.

**Inniswood Metro Gardens**, 940 Hempstead Road, Westerville, 895-6216. Inniswood Metro Gardens has a number of specialist feature gardens, including a memorial garden, rock garden, rose garden, conifer garden, sisters' garden and more.

**Wexner Center for the Arts**, 15th & High Street (OSU Campus), 292-0330. A slice of Soho in Columbus with contemporary works in all media. Peter Eisenman's building gets as much notice as the art (cafe and museum shop).

**Ohio Village & Historical Center**, 1982 Velma Avenue, 297-2300. Experience life in 19th century Ohio (Museum, library, seasonal events).

**Historic German Village** - Columbus' premiere downtown neighborhood is one of the preeminent historic districts in the United States. German Village is 233 acres of "living" history where the old meets the new and the result is a vibrant and charming community.

## **METRO PARKS**

### **Battelle Darby Creek**

Stretched along more than 14 miles of the Big and Little Darby creeks, Battelle Darby Creek is the largest Metro Park with more than 6,500 acres of prairies, fields and forests.

### **Blacklick Woods**

Opened in 1948, Blacklick Woods is the oldest and one of the busiest Metro Parks. The forest areas of this 632-acre park are laced with trails that wind through a swamp forest with white oak, pin oak and white ash along with red maple, red elm, shagbark, butternut hickory and dogwood.

### **Blacklick Woods Golf Course**

Blacklick Woods features two challenging courses and is rated one of the top ten most difficult public golf courses in Greater Columbus by Business First magazine.

### **Blendon Woods**

Spectacular stream cut ravines surrounded by beech-maple and oak-hickory forests highlight this 645-acre Metro Park.

### **Chestnut Ridge**

Chestnut Ridge provides a quick getaway from the noise of the city. Located southeast of Columbus, the park provides hiking trails, picnic areas, fishing, a playground and — most importantly — peace and quiet.

### **Clear Creek**

You may catch a glimpse of turkey, deer, ruffed grouse, coyote, black vultures or even see the traces of the elusive bobcat along the park's more than 15 miles of trails.

### **Glacier Ridge**

Named for the end moraine that was left behind when the Wisconsin Glacier retreated some 12,000 to 17,000 years ago, much of this Metro Park was used as farm land.

### **Heritage Trail**

The Heritage Trail is a 7-mile trail converted from abandoned right-of-way located in Franklin and Madison Counties in Central Ohio.

### **Highbanks**

Highbanks is appropriately named for its massive 100-foot high shale bluffs that tower over the Olentangy State Scenic River.

### **Inniswood**

Nestled within a scenic nature preserve, Inniswood Metro Gardens is a continual source of inspiration for Central Ohioans of all ages.

### **Pickerington Ponds**

Designated as one of Ohio's Important Birding Areas by Audubon Ohio, Pickerington Ponds is a premier spot for observing more than 260 species of birds.

### **Prairie Oaks**

Prairie Oaks features nearly 400 acres of lush prairies and grasslands.

### **Scioto Audubon**

Metro Parks has begun work on the 71-acre Scioto Audubon Metro Park. Although construction is ongoing, visitors can enjoy birding, fishing, boating, hiking and jogging. Audubon Ohio has begun construction on the Grange Insurance Audubon Center, which is slated to open in 2009.

### **Sharon Woods**

The 14-acre Schrock Lake serves as a focal point of this 761-acre Metro Park. The lake provides the setting for kids' fishing, bird watching and picnicking.

### **Slate Run**

Slate Run features a variety of habitats ranging from the open areas of grasslands, wetlands and meadows to the forested areas of beech, oak, hickory and sugar maple.

### **Slate Run Living Historical Farm**

Time has been turned back to the 1880s at Slate Run Living Historical Farm. Visitors can experience first-hand what life was like on an Ohio farm more than 100 years ago.

### **Three Creeks**

Named for the confluence where Alum, Big Walnut and Blacklick creeks join, this 1,156-acre park is operated through a partnership of Metro Parks and Columbus Recreation and Parks.

## **OTHER DISCOVERY SITES**

**Franklin Avenue** is one of the best preserved streets of a 19th century middle class neighborhood.

**Davis Youth Performing Arts** - 549 Franklin Avenue. The Davis Youth Performing Arts Center offer programs in theatre, dance, and music. Focuses include Shakespeare, magic, puppetry, improvisation, and more. The Davis programs also present an entire theatrical season.

**Columbus Museum of Art** - The museum has a significant European collection from the 16th century and a fine American collection from the 19th and 20th centuries. Nationally known artists with Columbus roots are also represented.

**COSI** (Center of Science and Industry). COSI provides an exciting and informative atmosphere for those of all ages to discover more about our environment, our accomplishments, our heritage, and ourselves. We motivate a desire toward a better understanding of science, industry, health, and history through involvement in exhibits, demonstrations,

and a variety of educational activities and experiences. COSI is for the enrichment of the individual and for a more rewarding life on our planet, Earth.

**The Thurber House** - The Thurber House is a non-profit literary center for readers and writers located in the historic former home of author, humorist, and New Yorker cartoonist James Thurber. The mission of Thurber House is to celebrate the written word for the education and entertainment of the broadest possible audience and to continue Thurber's legacy of humor. Our programs include the Thurber Prize for Humor, the only such recognition of humor writing in the country; a month-long residency for writers of children's literature; author readings; writing classes for children in grades K-12; a gallery of Thurber art and a museum of Thurber memorabilia. Thurber House is a unique national treasure..

**St. Paul A.M.E. Church**, established in 1823, is the second oldest African American congregation in Ohio and was active in the underground railroad.
